2025 Scholarship Announcement

The Kent Soil and Water Conservation District and Andelot, LLC are committed to helping Kent County high school students that plan to study agriculture or natural resources in college. The total amount of scholarships offered will be \$3,000.

- The first scholarship supported by Kent Soil and Water Conservation District and Andelot LLC will be awarded to **one student** and will be for \$1,000.
- The second scholarship is the S. Wicks Westcott Memorial Scholarship supported by the Kent Soil and Water Conservation District. It will be awarded to **two students**, each receiving \$1,000.

To be eligible for consideration for either scholarship the following prerequisites must be met.

1. Must have an academic cumulative grade point average of 2.5 or higher.

2. Show acceptance letter from an institution of higher education.

3. Must be pursing academic degree(s) in agriculture and/or natural sciences at an institution of higher education.

4. Must have completed at least four agricultural or natural resources related classes.

5. Supply one teacher recommendation and one recommendation from outside the school system.

6. Complete and submit the application and requested information

7. Application **deadline March 28, 2025**. Any application postmarked by the deadline date and received before April 4, 2025, will be considered. Application and other required information must be submitted to the District office or mailed to:
